Pledge of Allegiance was led by Commissioner Mead.

1. Commissioner Mead made a motion to discuss and pass the motion to officially determine the certified rate based on the calculation as \$2.6589 on each \$100.00 of taxable property within the boundaries of the City of Clinton; \$2.4945 on each of the taxable property within the boundaries of the City of Oak Ridge; and \$2.6903 on each \$100.00 of the taxable property in Oliver Springs, Rocky Top, Norris and rural Anderson County. Seconded by Commissioner Warfield. Voting aye: Fritts, Alderson, Meredith, Warfield, McKamey, White, Hitchcock, Mead, Creasey and Scott. Voting no: Wandell, Emert and Isbel. Absent: Bates, Biloski and Iwanski. Motion passed.

2. Commissioner Hitchcock made a motion that we reduce the tax rate that we just accepted by .05 cents. Seconded by Commissioner Isbel.

Motion withdrawn by the maker of the motion Commissioner Hitchcock and the second Commissioner Isbel.

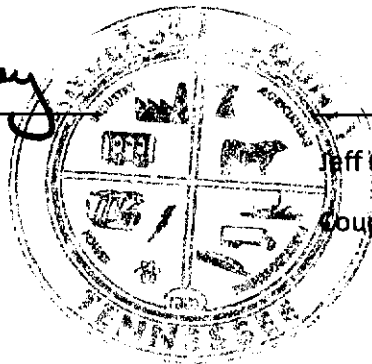
