Voting aye: Fritts, Jameson, Meredith, Denenberg, Mead, Creasey and Yager. Voting no: Wandell, Waddell, Anderson, Vowell, Isbel, McKamey, White, Scott and Smallridge. Motion failed.
- 4. Commissioner Denenberg made a motion to refer the EMS budget proposals back to Budget Committee for discussion. Seconded by Commissioner Vowell. Voting aye: Fritts, Wandell, Meredith, Waddell, Anderson, Vowell, Isbel, McKamey, White, Denenberg, Mead, Creasey and Scott. Voting no: Jameson, Yager and Smallridge. Motion passed.
- 5. Commissioner Fritts made a motion to refer back to Budget Committee all budgets. Seconded by Commissioner McKamey. Voting aye: Fritts, Wandell, Meredtih, Waddell, Vowell, Isbel, McKamey, White, Denenberg, Creasey, Scott, Yager and Smallridge. Voting no: Jameson, Anderson and Mead. Motion passed.
- 6. Commissioner Waddell made a motion to send back to Budget Committee that no tax increase be made. Seconded by Commissioner Anderson. Voting aye: Wandell, Waddell, Anderson, Isbel, McKamey, White and Scott. Voting no: Fritts, Jameson, Meredith, Vowell, Denenberg, Mead, Creasey, Yager and Smallridge. Motion failed.
