WHEREAS, the National Register of Historic Places is the official list of our Nation's historic places worthy of preservation. Authorized by the *National Historic Preservation Act of 1966*, the National Park Service's National Register of Historic Places is part of a national program to coordinate and support public and private efforts to identify, evaluate, and protect America's historic and archeological resources; and

WHEREAS, the home of Revolutionary War Soldier and American Patriot, David Hall located in the Claxton Community of Anderson County is worthy of this designation and has unique historical value to the creation of Anderson County; and

WHEREAS, David Hall and his twin brother, Samuel Hall fought together in the battle of King's Mountain which is considered to be a pivotal turning point of the Revolutionary War. In 1784 David Hall was awarded 428 acres in Tennessee by the United States government for his dedication, personal sacrifices and efforts as a Revolutionary War soldier and Indian spy. Brother Samuel bought an additional 100 acres in the Claxton community and the Hall brothers settled in Anderson County; and

WHEREAS, in 1799 David Hall built his historic log cabin, traveler's inn and tavern in the Claxton community that has stood the test of time for over 200 years; and

WHEREAS, the original discussions regarding the creation of Anderson County were held at the David Hall home place and tavern. With the assistance of 270 fellow settlers a petition was passed by the Tennessee General Assembly in 1801 creating Anderson County.

NOW THEREFORE, BE IT RESOLVED by the Anderson County Board of Commissioners meeting in regular session this 15th day of August 2011 that we respectfully request:

- 1) The National Park Service and Tennessee Historical Commission place the David Hall home on the National Historic Site Registry.
