

## **RESOLUTION NO. 12-10-453**

A RESOLUTION TO ENACT A TWO DOLLAR (\$2.00) LITIGATION TAX ON ALL MATTERS BEFORE THE ANDERSON COUNTY GENERAL SESSIONS COURTS AND JUVENILE COURT WITH THE PROCEEDS TO BE USED EXCLUSIVELY TO SUPPORT THE ANDERSON COUNTY VICTIM-OFFENDER COMMUNITY MEDIATION PROGRAM.

WHEREAS, the Anderson County Legislative Body recognizes that the resolution of felony, misdemeanor and juvenile delinquent crimes and disputes can be costly and complex in a judicial setting where the parties involved are necessarily in an adversarial posture and subject to formalized judicial procedures and requirements; and

WHEREAS, the Anderson County Legislative Body acknowledges that alternative dispute resolution programs, such as Victim-Offender Mediation Programs, can greatly assist the courts and community by providing informal voluntary mediation services which seek to provide beneficial no cost services to the citizens of Anderson County; and

WHEREAS, Victim-offender Mediation Programs encourage volunteer community participation in the development, administration, and oversight of local programs to facilitate the informal resolution of disputes between and among members of the community and to hold criminal offenders accountable to their victims; and

WHEREAS, Victim-offender Mediation Programs can meet the needs of the county's citizens and assist the overburdened judicial system by providing forums in which persons involved may voluntarily participate in the resolution of disputes in an informal, less costly and less adversarial atmosphere; and

WHEREAS, Tennessee Code Annotated §§ 16-20-101 et seq. provides legal authority for Tennessee counties and municipalities to create and operate local Victim-offender Mediation Centers and Programs to assist local courts with alternative victim-offender dispute resolution; and

WHEREAS, Anderson County was the first Tennessee county to create a Victim-offender Mediation Program in 1986, and it has since developed into a model program for other Tennessee communities to create and operate their own Victim-offender Mediation Programs; and

WHEREAS, since the program's inception in 1986 the Anderson County Victim-offender Community Mediation Program staff has trained and certified over two hundred and fifty members of the community. The agency maintains an active mediator roster of 40 to 50 mediators in mediation services and skills; and

WHEREAS, independent studies have been commissioned and conducted by the University of Tennessee, School of Social Work, which attempted to measure and document the success rate of the Anderson County Victim-offender Community Mediation Program. Both studies concluded that juvenile offenders referred to the program are fifty percent (50%) less likely to commit criminal acts in the future, and if the offender does commit additional criminal acts in the future, they tend to commit crimes that are less severe than the former criminal act; and

WHEREAS, the Anderson County Victim-offender Community Mediation Program receives referrals from the Anderson County court systems and the community at large, and has continually maintained an overall restitution success rate of ninety-five percent (95%) or better;

and

WHEREAS, to continue to meet these referrals from courts and the community and to offset budgetary shortfalls, the Board of Directors of the Anderson County Victim-offender Community Mediation Program respectfully requests the Anderson County Legislative Body to enact a two dollar (\$2.00) litigation tax authorized by Tennessee law and exclusively distribute the proceeds on a monthly basis to the Anderson County Victim-offender Community Mediation Program.

WHEREAS, Tennessee Code Annotated § 16-20-106 (g)(1) provides legal authority for county legislative bodies to enact by two-thirds (2/3) majority vote a two dollar (\$2.00) litigation tax to be assessed as court costs in all matters before the local general sessions courts and juvenile courts and to use the revenues generated by this litigation tax to financially support community based Victim-offender Mediation Programs; and

WHEREAS, the Anderson County Legislative Body wishes to avail themselves of this power and authority and lawfully enact a two dollar (\$2.00) litigation tax on all matters in general sessions or juvenile courts and distribute this litigation tax to the Anderson County Victim-offender Community Mediation Program.

**NOW, THEREFORE, BE IT RESOLVED** by the Anderson County Legislative body meeting in quarterly day session this 15<sup>th</sup> day of October, 2012, in Clinton, Tennessee, that:

**SECTION ONE.** Henceforth, an additional two dollar (\$2.00) litigation tax shall be imposed on all matters before the Anderson County General Sessions Courts and Juvenile Court.

**SECTION TWO.** The proceeds from the two dollar (\$2.00) litigation tax shall be exclusively used by and distributed to the Anderson County Victim-offender Community Mediation Program.

**SECTION THREE.** Any revenue generated by this litigation tax shall be held in a separate designated account and shall be distributed to the Anderson County Victim-offender Community Mediation Program on a monthly basis.

**SECTION FOUR.** The taxes levied in accordance with the foregoing shall be in addition to any other litigation taxes and costs lawfully enacted in Anderson County and the State of Tennessee.

SECTION FIVE. This resolution shall become effective immediately upon two-thirds (2/3) majority approval of the Anderson County Legislative Body the public welfare requiring it.

# **AGREEMENT**

FOR REPAYMENT OF THE UNITED STATES DEPARTMENT OF AGRICULTURE RURAL DEVELOPMENT LOAN FOR CONSTRUCTION OF THE NEW BRICEVILLE LIBRARY.

This Agreement made by and between the Parties of Anderson County, Tennessee, a governmental entity and political subdivision of the State of Tennessee (hereinafter "County") and the Briceville and Anderson County Public Library Foundation, a not-for-profit entity formed under the laws of the State of Tennessee and United States Internal Revenue Service regulations (hereinafter "Foundation") do hereby agree without reservation to the following conditions and covenants, the sufficiency and consideration of which are hereby acknowledged and accepted.

### WITNESSETH:

WHEREAS, the Parties hereto have undertaken a mutual endeavor to construct a new Briceville Library (hereinafter the "Project") for the use and enjoyment of all Anderson County citizens; and

WHEREAS, the Project will be funded by private donations; Grants from Anderson County, and the State of Tennessee; and, a United States Department of Agriculture (USDA) Rural Development loan; and

WHEREAS, the USDA Rural Development loan has been approved in the amount of one hundred and twenty-five thousand dollars (\$125,000.00) at an interest rate of three and three eights percent (3.375%) for a term not to exceed forty (40) years with an annual installment of principle and interest not to exceed five thousand, eight hundred and fifty-six dollars (\$5,856.00); and

WHEREAS, the Parties hereto wish to memorialize and agree to repayment terms for the life of the USDA Rural Development loan.

THEREFORE, the Parties acting under proper legal authority agree as follows:

SECTION 1: County's Obligation.

County agrees to pay the first four annual payments not to exceed five thousand, eight hundred and fifty-six dollars (\$5,856.00) per year.

#### **SECTION 2:** Foundation's Obligation.

Foundation agrees to pay the remaining payments due for years five through forty, including all remaining balances to sufficiently retire the USDA Rural Development loan.

#### Indemnification. **SECTION 3:**

It is further contemplated that if Foundation fails to perform or breaches the provisions of this Agreement, and in order for County to sufficiently retire the General Obligation Bond related to this Project and preserve its collateral, County may have to provide funds to make additional payments. If this occurs, Foundation agrees to indemnify and reimburse all additional payments made by County under the terms of the General Obligation Bond within the payment time limits and before expiration of the General Obligation Bond indebtedness.

#### **SECTION 4:** Release.

Foundation hereby agrees to release and hold County harmless from and against any and all claims, lawsuits, or the like associated with County's performance of this agreement, or as it relates to the past, present, or future financial condition of the County or the performance of Foundation's obligations under this Agreement.

#### **SECTION 5:** Default.

In the event of default by the Foundation hereto, the County may bring suit against the Foundation to enforce the terms of this Agreement. In such event, the prevailing Party shall be entitled to recover any remedies available at law and/or equity including reasonable attorney's fees and costs associated with the default.

#### No Oral Modification. **SECTION 6:**

No modification, amendment, supplement to or waiver of this Agreement or any of its provisions shall be binding upon the Parties hereto unless made in writing and duly signed by all the Parties.

### **SECTION 7:**

A failure of any Party to exercise any right provided for herein, shall not be deemed to be a waiver of any right hereunder.

#### Entire Agreement. **SECTION 8:**

This Agreement sets forth the entire understanding of the Parties as to the subject matter and may not be modified except in a writing executed by all Parties.

#### Severability. **SECTION 9:**

In the event any one or more of the provisions of this Agreement is invalid or otherwise unenforceable, the enforceability of the remaining provisions shall be unimpaired.

#### Cancellation. **SECTION 10:**

In the event any Party materially breaches, defaults or fails to perform hereunder, this Agreement may be cancelled by the other non-breaching Party with cause on thirty (30) days written notice to the other, if the event constituting the breach, default, or failure is not cured during that time. Nothing contained in this section prohibits the non-breaching Party from initiating legal proceedings to recover costs incurred by the breach or legal actions mandating complete and specific performance under the terms of this Agreement.

#### Exhibits. SECTION 11:

Any Exhibits attached hereto or incorporated herein are made a part of this Agreement for all purposes. The expression "this Agreement" means the body of this Agreement and the Exhibits.

#### Multiple Counterparts; Effectiveness. **SECTION 12:**

This Agreement may be executed in multiple counterparts, each of which shall be deemed an original for all purposes and all of which shall be deemed, collectively, one Agreement. This Agreement shall become effective when executed and delivered by all the Parties.

#### Jurisdiction. SECTION 13:

Each Party hereby irrevocably consents to the jurisdiction of all state courts sitting in Anderson County, Tennessee or all federal courts sitting in Knoxville, Tennessee and agrees that venue for any legal action brought in connection with this Agreement shall lie exclusively in such courts.

**SECTION 14:** Binding Effect.

This Agreement shall be binding upon and inure to the benefit of the Parties and upon their respective successors, heirs, or assigns.

SECTION 15: Choice of Law.

This Agreement shall be governed and construed in accordance with the laws of the State of Tennessee.

SECTION 16: Notice.

Any notice required or provided pursuant to this Agreement shall be in writing and sent or delivered to the Parties.

SECTION 17: Titles and Subtitles.

Titles of paragraphs and subparagraphs are for convenient reference only and shall not have the effect of modifying, amending, or changing the express terms of this Agreement.

SECTION 18: Assignment.

This Agreement shall be assignable only upon the written consent of the non-assigning Party. Consent to an assignment shall not be unreasonably withheld. In the event of assignment or succession, the terms and conditions of this Agreement shall be binding upon the Parties and their successors, assigns, heirs, executors, and/or administrators.

SECTION 19: Further Documentation.

The Parties agree for themselves and their successors and assigns to execute any and all instruments in writing which are or may become necessary or proper to carry out the purpose and intent of this Agreement.

# **RESOLUTION NO. 12-10-457**

RESOLUTION TO ALLOW LIMITED DEER HUNTING ON COUNTY OWNED PROPERTY CONSISTING OF ONLY THE BLOCKHOUSE VALLEY FORMER LANDFILL SITE AND ANDERSON COUNTY PARK PROPERTIES, AND TO ADOPT RESTRICTIONS AND PROCEDURES FOR PERMITS RELATED THERETO.

WHEREAS, on August 17, 2009 the Anderson County Board of Commissioners passed Resolution No. 09-321 declaring the Blockhouse Valley Landfill site to be a nature preserve, recreational park and outdoor classroom. This same Resolution prohibited hunting on the property; and

WHEREAS, currently the need exits to allow limited and restricted hunting on the property to properly control the deer population which has caused damages to the mandated Tennessee Department of Environment and Conservation (TDEC) remediation projects underway at the former Blockhouse Valley Landfill site; and

WHEREAS, Anderson County Park has also experienced an overburdened deer population that has caused accidents on Park Road and adjacent county roads and damages to adjacent property owners; and

WHEREAS, the Anderson County Board of Commissioners now desires to allow limited and restricted hunting permits on these two properties, and to adopt regulations and procedures designed to properly reduce the deer population to healthy levels through controlled management hunting.

NOW THEREFORE BE IT RESOLVED, by the Anderson County Board of Commissioners meeting in quarterly day session this 15<sup>th</sup> day of October, 2012 that we allow limited and restricted hunting on the Blockhouse Valley and Anderson County Park sites to better control the deer population in effort to reduce the deer herd to a healthy population, protect TDEC remediation efforts underway at the Blockhouse Valley site, and protect the health, safety and welfare of area citizens, subject to the following restrictions, limitations and procedures:

SECTION 1. Hunting on the subject property will only be permissible to valid permit holders. Hunting is limited to the deer population only. Other species hunting shall be allowed only by approval of the Board of Commissioners. Hunters must agree to comply with all hunting regulations set forth and adopted by the Tennessee Wildlife Resources Agency (TWRA) including but not limited to: licensing, Hunter Safety Course requirements, safety regulations, hunting seasons, and bag limits. (See Exhibit 1)

SECTION 2. All permitted hunters shall agree to sign the waiver and release of liability document and shall also agree to the terms and restrictions set forth. Permitted hunters shall display the permit in a clear and conspicuous manner while hunting on the subject property. Parking passes shall be displayed on the vehicle's dashboard while on the subject property.

SECTION 3. TWRA and Director of Anderson County Parks shall monitor and enforce hunting restrictions on said subject property and report violations to the Anderson County Law Director or District Attorney General for future legal actions and prosecution of unlawful activities. Anderson County reserves the right to cancel any permits due to non-compliance reported to, and by the TWRA and the Director of Anderson County Parks.

SECTION 4. Permits shall be issued only for three day increments (Monday through Wednesday and Thursday through Saturday) through random lottery drawings held and conducted by the County Mayor. No Sunday hunting. Applications and requests for the 2012/2013 deer hunting season must be submitted by phone application by October 30, 2012 by calling 865-457-6291. Lottery drawing will be held in the Office of County Mayor on October 31, 2012 at 2:00 P.M.

SECTION 5. Only archery and crossbows are allowable at the Anderson County Park property. Archery, crossbows, muzzle loaded firearms and shotguns are allowable at the Blockhouse Valley site. All hunting apparatus and weapons shall conform to TWRA regulations and permitted seasonal hunting requirements.

SECTION 6. No more than four individual three-day permits shall be issued for the Blockhouse Valley site and no more than two three-day permits shall be issued for the Anderson County Park property. Permitted hunters wishing to participate in the Young Sportsman Hunts may request one additional permit for Young Sportsman qualified hunters.

SECTION 7. Hunting is prohibited within one hundred (100) yards from adjacent land owners relative to the Anderson County Park. Hunting is prohibited within two hundred (200) yards from adjacent land owners contiguous to the Blockhouse Valley site. Property maps are reviewable in advance on-line at the Anderson County Register of Deeds and Assessor of Property websites. Maps, permits and parking passes will be provided to each permitted hunter when permit is received.

SECTION 8. County employees and family members are expressly allowed to participate provided that they are selected by the random lottery drawing conducted by the County Mayor.

SECTION 9. Any previous Resolution in conflict with this Resolution is expressly repealed as limited to existing conflicted provisions contained therein.

SECTION 10. This Resolution shall take effect immediately, the public welfare requiring same.
