

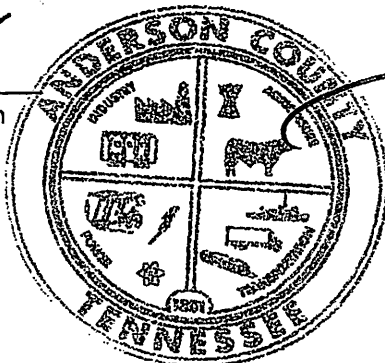



Forever known as the "Mule Man" of Anderson County

WHEREAS, on October 28th one of the most charismatic and inspirational citizens of Anderson County peacefully passed away in his Dutch Valley home at the age of 67; and

WHEREAS, Joe Long was admired by all as a hard-working man that blazed his own trail in life leaving love and compassion to everyone he knew. He was the first to help a neighbor in need, the first to help an ailing animal, the first to show others the love and beauty of Dutch Valley, the first to talk of the wonderful legacy and heritage of the Long family of Anderson County, and above all, the first to thank the Lord for his many blessings in life; and

WHEREAS, Joe was a hard-working man that rose before sunrise to begin a long day working with his nephew and tending to his famous mule team. His personal favorites were two highly-spirited jacks known as Amos and Fred that were considered his family. He was always in attendance at *Mule Days* in Columbia, TN, where he became a world record holder for hitching forty-two (42) mules to one wagon. Joe was a charter member of the *East Tennessee Draft Horse and Mule Association*, organizer of the *Bicentennial Wagon Trail* across Tennessee and was a famous invitee and crowd favorite at the *Macy's Thanksgiving Day Parade*. Joe was often called upon to be a consultant and advisor to the *Heartland Series* and

WHEREAS, he was an accomplished carpenter constructing mule-drawn wagons, hitches and wheels from scrap lumber. Fittingly, Joe made his own pine box coffin lined in used burlap. Joe's heels were dug in deep in the Dutch Valley soil but also in our cultural heritage that is fast becoming a distant memory; and

WHEREAS, Joe lived life the right way, showing kindness and compassion to his fellow man. He put others and his animals first, before his own needs. In a time of need, Joe was there for anyone who needed a helping hand. His strong work ethic and simple way of life should be a road map to happiness for us all.


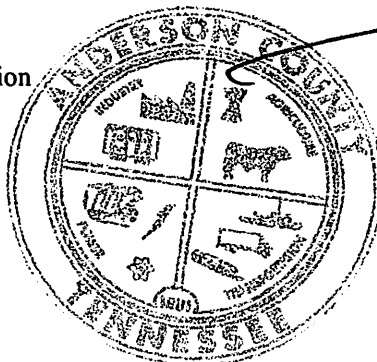



RESOLUTION NO. 19-11-783

RESOLUTION TO RE-ESTABLISH AND LEVY A LITIGATION TAX ON ALL CRIMINAL AND CIVIL CASES IN ALL COURTS, AND CONTRIBUTE BEER BOARD FINES TO CREATE A CONTINUOUS FUNDING STREAM FOR THE USE AND BENEFIT OF ASAP OF ANDERSON.

WHEREAS, on February 22, 2016 the Anderson County Board of Commissioners passed *Resolution 16-03-576* requesting the Tennessee General Assembly to amend *Tenn. Code Ann. § 67-4-601* to allow Anderson County to establish and levy a litigation tax up to twenty-five dollars (\$25.00) per case in the General Sessions Court to fund drug awareness, treatment and prevention programs;

WHEREAS, on March 29, 2016 the Governor signed *Public Chapter No. 661* amending *Tenn. Code Ann. § 67-4-601* to allow Anderson County to establish and levy a litigation tax for the foregoing purposes;

WHEREAS, the enabling authority has now been codified at *Tenn. Code Ann. § 67-4-601(h)* and allows the litigation tax to be created upon a two-thirds (2/3) vote of the Anderson County Board of Commissioners;

WHEREAS, from time to time the Anderson County Beer Board assesses fines against beer permit holders for the sale of alcohol to underage persons and other violations of local alcohol related regulations. ASAP of Anderson has been an important partner in reducing underage sales in our community and the Board of Commissioners desires to contribute revenue received from the Beer Board fines and penalties to ASAP of Anderson to fund compliance checks and continued efforts to curb underage alcohol sales in our community.


NOW THEREFORE, BE IT RESOLVED by the Anderson County Board of Commissioners meeting in regular session this 18th day of November 2019 that we hereby re-establish and levy a litigation tax pursuant to *Tenn. Code Ann. § 67-4-601(h)* of ten dollars (\$10.00) on all criminal cases and five dollars (\$5.00) on all civil cases filed in all courts where not precluded by state law, for the use and benefit of ASAP of Anderson in an effort to fund drug awareness, education, treatment and prevention programs.

BE IT FURTHER RESOLVED that all fines assessed by the County Beer Board shall also be directed to ASAP to continue its community mission. These funds shall be collected by the County Clerk and dispersed by the Finance Department as received.



RESOLUTION TO ADOPT AND INCORPORATE ALL AMENDMENTS PASSED BY THE GENERAL ASSEMBLY RELATED TO THE JACKSON LAW FOR SOLID WASTE DISPOSAL SINCE ADOPTION OF PRIOR RESOLUTION 12-443 ON AUGUST 20, 2012.

WHEREAS, the general law codified in Tennessee Code Annotated, Title 68, Chapter 211, part 7, known as the "Jackson Law", provides for local approval of the construction or changes in classification of privately owned landfills; and,


WHEREAS, the procedures of the Jackson Law cannot be used by a county unless the county legislative body approves of its use by a two-thirds (2/3) majority vote; and,

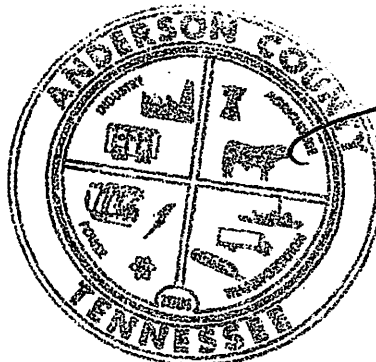
WHEREAS, the people of Anderson County desire that the Anderson County Legislative Body approve or deny the construction of privately owned landfills for solid waste disposal before such landfills are constructed in the county or changes in classification occur including those constructed within the boundaries of municipalities in Anderson County and specifically including those landfills taking waste from other counties to disposal sites within Anderson County.


NOW THEREFORE, BE IT RESOLVED by two-thirds (2/3) majority vote of the County Legislative Body of Anderson County, Tennessee, meeting in regular session on this 18th day of November, 2019, that we hereby adopt all provisions and amendments approved by the Tennessee General Assembly since adoption of Anderson County Resolution 12-443 on August 20, 2012 to Tennessee Code Annotated, Title 68, Chapter 211, Part 7,(otherwise known as the "Jackson Law") specifically sections 68-211-701 through 68-211-707, regarding county legislative body approval of new or classification changes to landfills constructed for solid waste disposal and those landfills disposing of waste transferred to Anderson County from other counties are hereby approved and are applicable in Anderson County, Tennessee from the date of approval of this Resolution.


