A RESOLUTION RECOGNIZING TIM THOMPSON FOR HIS 27 YEARS OF AIDING ECONOMIC AND INDUSTRIAL PROSPERITY IN THE STATE OF TENNESSEE AND ANDERSON COUNTY

WHEREAS, Tim Thompson has been a long-time fixture in the State of Tennessee and Anderson County, helping bring an estimated 18,000 jobs and more than \$3.5 billion in investments to the State through economic and industrial development; and

WHEREAS, Tim Thompson was managing the governor's office in Knoxville when it was announced in 1992 that he was moving to the State's Department of Economic and Community Development; and

Final Draft - Proposed Amendment to the Anderson County Zoning Resolution

New Section: 075-070

Public Notice: Use on Review; Re-zoning; Variance and/or Special Exception Requests.

Notwithstanding any other provision of law or regulation to the contrary, including those embodied in this Resolution and specifically including Section 05-060 (Amendments to the Zoning Resolution), any request for rezoning, variance or special exception shall comply with the minimum standards embodied in *Tennessee Code Annotated*, *Title 13*, *Chapters 3 and 7*; however, nothing contained herein shall be deemed to expand the requirements of *Tennessee Code Annotated* and failure to comply with these recommendations shall not in any way nullify or void any re-zoning, variance or special exception granted by the Planning Commission, Board of Zoning Appeals or Board of Commissioners provided the minimum standards of public notice embodied in Tennessee law have been satisfied. Henceforth, the following public notice recommendations are established in an effort to provide additional efforts to further achieve adequate notice to the general public and those property owners immediately adjacent to, and surrounding the subject property.

Prior to any official public meeting and/or public hearing where any re-zoning, variance or special exception will be considered for approval by the Board of Zoning Appeals, Planning Commission, or Board of County Commissioners, the following public notice requirements shall be completed by the Anderson County Planning and Community Development Department:

- A) Newspaper of General Circulation in the County no less than fifteen (15) days prior to the meeting where the matter will be discussed and considered for approval the date, time, location of the meeting and proposed action to be taken or considered shall be published in at least two different newspapers regularly published and circulated in Anderson County. At least one of the newspapers shall be published in the county seat of Clinton, Tennessee and the other shall be regularly circulated in the locale nearest the property requesting the zoning change, variance or special exception. The published public notice shall also contain the applicant's name, address, and map and parcel number for the subject property. Nothing contained in this resolution shall prevent the Planning and Community Development Department from charging the owner/applicant reasonable compensatory fees for the mandatory notice publications listed in this section.
- B) Anderson County Television (ACTV) no less than fifteen (15) days prior to the meeting where the matter will be discussed and considered for approval the date, time, location of the meeting and proposed action to be taken shall be displayed on ACTV for no less than five (5) consecutive days prior to the meeting date. The displayed public notice shall also contain the owner/applicant's name, address, map and parcel number for the subject property.

- C) Anderson County Website the meeting agenda for any meeting or public hearing of the Board of Zoning Appeals, Planning Commission and Board of County Commissioners where the proposed action will be discussed and considered for approval shall be displayed on the Anderson County Government website no later than the day after the agenda deadline and shall remain on the website until the day after the meeting date. The agenda shall specifically identify the proposed request or action to be taken, name of owner/applicant, physical address and the map and parcel number of the subject property, including date, time and location of the meeting or public hearing where the matter will be discussed and/or considered for approval.
- D) Certified Mail Notification The owner/applicant of the subject property shall work with the Planning and Community Development Department to send all adjacent or contiguous property owners (including those property owners immediately across any public or private roadways) written notification of the meeting or public hearing date, time, location of the meeting and proposed action to be taken, no less than fifteen (15) days prior to the meeting where the matter will be discussed and considered for approval. The certified mail public notice shall also contain the owner/applicant's name, address, and map and parcel number for the subject property. The owner/applicant will at all times be financially responsible for the mailing and costs associated therewith for the certified The Planning and Community Development Department will mail notification(s). address and send all written notifications to the affected adjacent property owners and shall retain all return receipts demonstrating the adjacent property owners were sent notice of the proposed action and date, time and location of the meeting or public hearing. Addresses contained in the official property tax records of Anderson County will The Planning and Community Development Department may charge be utilized. reasonable expenses to the owner/applicant for the identification of the adjacent landowners, sending of the certified mail notices and retention of the receipt cards.
- E) Property Posting and Signage Each property shall be continuously posted in a clear and conspicuous manner for a period of no less than fifteen (15) days prior to the meeting and/or public hearing where the matter will be discussed and considered for approval. Posting shall specifically state the date, time, location of the meeting and proposed action to be taken and shall also include the owner/applicant's name, address and map and parcel number of the subject property. Signage shall be no less than two (2) feet by four (4) feet utilizing contrasting colors; however, this specific size requirement shall not be imposed until the current on-hand inventory has been exhausted, but in no case no later than December 31, 2022. The Building Commissioner shall have the authority to design and approve said signage and assign staff member(s) to post the subject property at the most desirable location on the subject property for accomplishing public notice. Posting within the county right-of-way for public roads bordering subject property is preferred. All required signage will be the responsibility of the Community Planning and Development Department.

BE IT FURTHER RESOLVED that Terry Frank, Anderson County Mayor, is authorized to execute, for and on behalf of Anderson County, the transmittal of a request for payment and an agreement with DOE for payment-in-lieu-of-taxes in the amount of \$653,790.64 for 2019.

RE: Clarification about FFA Grant Funding & Request for Additional Funding

Dear Senator Alexander:

Thank you for your continued leadership for Tennessee and our nation. We are particularly grateful for your work leading the Senate Appropriations Committee by producing a bill that provides funding to modernize our nuclear weapons facilities at Y-12 and accelerate cleanup of hazardous materials and facilities at the East Tennessee Technology Park, the Oak Ridge National Laboratory and the Y-12 National Security Complex. While these enhancements are positive, there was an outcome of the 2020 Energy and Water Appropriations bill, S. 2470, on September 12, 2019, that may negate their positive potential impact on our state. The bill reduces the prior level of funding for an area DOE describes as Community and Regulatory Support. Additionally, the accompanying committee report references funding for Community and Regulatory Support at the Oak Ridge Reservation and states that "none of these funds shall be applied to the Federal Facilities Agreement grant."

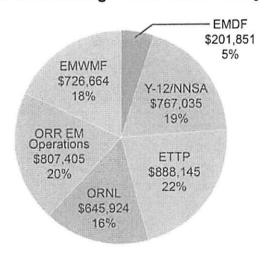
The Federal Facility Agreement ("FFA") created the procedures and responsibilities of the State of Tennessee, the U.S. Environmental Protection Agency, and the U.S. Department of Energy to ensure the 35,000 acre Oak Ridge Reservation (ORR) Superfund site is cleaned up to a level that is protective of human health and the environment. Since 1991, the FFA has allowed these parties to work cooperatively towards this goal. On the state side, the Tennessee Department of Environment and Conservation, through its Division of Remediation Oak Ridge Office (DoR-OR), has regulatory responsibility to oversee, evaluate and approve the planning, selection, and implementation of the Comprehensive Environmental Response Compensation and Liability Act (CERCLA), 42 USC §9601 et. seq., response actions on the ORR. This work includes the management of ETTP, Y-12, and ORNL; the existing hazardous mixed-waste landfill (EMWMF); and remediation of groundwater.

A provision within the FFA recognizes the federal government's legal obligation to reimburse the state's costs under CERCLA and provides for a specific funding mechanism for DOE to use. Historically, the funding mechanism has taken the form of a series of grants usually made for five-year terms and funded annually. The grants have delivered the financial support for TDEC's work evaluating and advancing DOE's assessment and clean-up activities on the ORR. For nearly 30 years, this agreement, work plan and concurrent federal funding has facilitated effective and protective cleanup for both the ORR and surrounding East Tennessee communities. The appropriations language from September 12, 2019, puts the state's ability to perform its role, the rate of clean-up progress and our mission for Oak Ridge at risk.

I recognize that there is active discussion between DOE, EPA and TDEC on important technical matters, such as the DOE proposed Environmental Management Disposal Facility (EMDF) onsite landfill. However, this step to eliminate DOE funding for TDEC's work at Oak Ridge under the FFA might be based on a lack of understanding regarding present TDEC workload on the ORR and the mistaken belief that if there is no EMDF landfill, then required DOE oversight work would immediately cease or decrease on the ORR. As such, it may be helpful to share information regarding TDEC's responsibilities and required activities under the FFA so your office would be aware of the scope of work in which our staff is engaged.

The current FFA Annual Work Plan (7/1/19-6/30/20) reflects required work by TDEC DoR-OR to provide coordination, review, comment and approval of each activity phase of the CERCLA process on the ORR. The 11-page plan's scope of work (attached) includes 13 major assignment areas, but the EMDF is *just one* of these areas, noted by two sentences in the document. Instead, the vast majority of DoR-OR work involves oversight, evaluation and approval for the planning, selection and implementation of CERCLA actions related to ETTP, Y-12, ORNL and the operational EMWMF.

The proposed EMDF is a small part of the overall cleanup effort for the ORR, and represents *only* 5% of the funded work carried out by DoR-Oak Ridge.

Within the set of work activities undertaken by DoR-OR is review and approval of DOE documents. There are more than two dozen different types of documents designated for our staff to evaluate and approve, including proposed plans and records of decision. It's worth noting that the DOE-proposed EMDF is just one of these proposed projects under review. Many more projects are ongoing and in various steps of the process that will require action taken by DoR-OR staff.

When I visited your office with some of my staff in July, we spoke of the need to make decisions on the particular EMDF project. We then had a follow-up meeting with DOE and congressional staff in Nashville and focused on Record of Decision (ROD) language. The FFA follows the federal National Contingency Plan (NCP), 40 CFR part 300, regulations for performance on the investigation and cleanup process outlined for CERCLA. And, each of the documents requires regulatory approval by the state and EPA for DOE to move forward in the process. Regrettably, following the meeting in Nashville with DOE, we spent a couple of months in discussion between TDEC, DOE and EPA regarding a key matter related to the depth of the groundwater relative to the liner of the proposed facility. I am pleased to report that we have addressed that one major concern - "ROD language" - and are prepared to move forward to resolve other issues in the set of seven primary concerns outlined with you and your office.

I am sharing the big picture because of the role TDEC's DoR-OR plays in establishing, reviewing and adjusting annual priorities and milestones for DOE's comprehensive ORR "Planning Case." Even as "plus ups" in the appropriations process may accelerate cleanup and facilitate projects for the ORR, the DoR-OR is responsible for approving and overseeing those activities and all the remaining work required to de-list the ORR from the National Priorities List (NPL). If the DoR-Oak Ridge Office is not adequately staffed and funded to review and approve the wide range of work underway and variety of critical projects planned for the ORR, then DOE cleanup could slow dramatically, if not stop altogether.

In light of the information provided herein and the progress on the ROD language, I am requesting your assistance with restoring the DoR-OR office funding, removing the restriction as to the FFA grant, and also that consideration be given to increasing DoR-OR funding commensurate with an increase in the scope of work on the proposed EMDF as well as related to the Environmental Management (EM) program on the Oak Ridge Reservation.

The ORR is arguably one of the most complex Superfund (NPL) sites in the United States in terms of volume and diversity of contaminants released to the environment. What makes the ORR even more unique is its proximity to significant populations and vibrant natural resources. For nearly three decades, the State of Tennessee, DOE, and EPA have worked under an effective FFA where oversight from the DoR-Oak Ridge Office has supported:

- o Demolition of more than 5.5M square feet of structures
- Disposal of 28 million cubic feet of waste
- o Prevention of 4.61 tons of mercury entering the environment
- o Management/treatment of more than 782 million gallons of low-level wastewater
- o Transfer of more than 4,700 acres of land for reuse:
 - 1,281 acres for reindustrialization
 - 3,470 acres for conservation

Even in the midst of our dialogue over the proposed EMDF, this critical cleanup endeavor continues and TDEC remains committed to a constructive working relationship with DOE to ensure compliance with approximately 39 negotiated milestones for environmental cleanup over the next three years, as documented in the FFA.

I began with a salute to your demonstrated leadership and ability to take the long-view throughout your extraordinary public service to our state and nation. I am confident you see the need and benefit of enduring congressional support for the state's mission in Oak Ridge by continued funding for FFA activities that will enable vital cleanup for the ORR. These are incredibly complicated matters - on technical, environmental, fiscal and political levels - so I welcome your insight, input, and feedback on these important issues so we can continue moving forward for Tennessee.
