



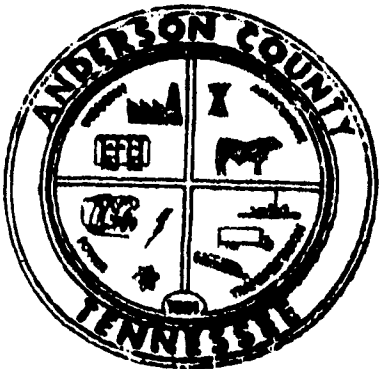

**RESOLUTION NO. 08-306**

**A RESOLUTION TO ESTABLISH A RECYCLING PROGRAM FOR ANDERSON COUNTY GOVERNMENT AND TO ENCOURAGE PARTICIPATION FROM OTHER GOVERNMENTAL ENTITIES, AREA BUSINESSES AND CITIZENS.**

**WHEREAS**, in the United States we throw away 162 million tons of garbage each year. The average American citizen throws away four to six pounds of trash per day. About 80% of what Americans throw away is recyclable, but less 25% of our trash is recycled. The United States composes 5% of the world's population, but uses 25% of the world's natural resources, and

**WHEREAS**, if governments, businesses and our citizens collectively recycled paper, aluminum, plastic, glass, tires, tin and steel we could reduce our landfill deposits by 25% within the next twenty-five years, and

**WHEREAS**, the majority of our landfill trash is paper. Paper items are one of the easiest to recycle. Making new paper from old paper uses up to 55% less energy and reduces related air pollution by 95%. Recycling one ton of paper saves seventeen trees, two barrels of oil (enough to run the average car for 1260 miles), 4100 kilowatts of electricity, (enough power for the average home for six months), 3.2 cubic yards of landfill space and sixty pounds of air pollution. Those seventeen trees could have absorbed 250 pounds of carbon dioxide each year. Each day American businesses generate enough paper to circle the globe at least forty times. If all Sunday papers were recycled, more than 550,000 trees could be saved each week or 26 million trees per year, and

**WHEREAS**, one of the most efficient items to recycle is aluminum. More than 95% of all canned drinks are sold in aluminum cans. In fact, old aluminum cans can be used to make everything from new aluminum cans to airplanes, trucks, ships and skyscrapers. Americans throw away enough aluminum to rebuild our entire fleet of commercial airplanes every three months. Recycling just one aluminum can will save enough energy to operate a television for three hours. Aluminum is made from bauxite ore that we purchase from other countries. The process of making aluminum from bauxite uses considerable amounts of energy. When aluminum is recycled it saves 95% of the energy used to initially process bauxite, and

**WHEREAS**, a lot of our country's food is sold in tin cans. These cans are made of steel coated with a thin layer of tin. Over 3 million tons of tin cans are deposited in our landfills each year. To make matters worse, tin is not mined in North America and our country must import expensive shipments of tin from other countries to satisfy the demand of the food industry. It takes over one hundred years for a tin can to decompose in a landfill. If all potential steel products were recycled it could save enough energy to power 18 million homes each year or power the entire City of Los Angeles for eight years, and

**WHEREAS**, glass items are easily recycled by a simple sterilization technique or melted down and remanufactured into new glass containers. The average American family buys more than one 150 glass containers each year but less than 10% are recycled. Recycling glass instead of making it from silica sand reduces mining waste by 70%, saves 50% of the water used in the production process and can decrease air pollution by 20%, and

**WHEREAS**, over 60 billion pounds of plastic is produced each year, but only about 3.5 % of all plastics are recycled. Two million birds and one hundred thousand mammals are killed each year from discarded plastic. Some plastic containers take over one hundred years to decompose in our landfills. Other plastic containers made of Styrofoam and used predominantly in the fast food industry never decompose. Plastic can be recycled into a variety of products from new plastic containers to park benches and playground equipment, and

**WHEREAS**, motor oil and grease can easily be recycled into new petroleum based products. Most motor oil can be cleaned and restored. Unlike the popular marketing strategies, motor oil doesn't wear out. Over four hundred million gallons of dirty oil and grease are dumped each year in the ground and streams of our country. This causes irreversible damage to our ground water supplies and the quality of the water in our lakes and streams. Four hundred million gallons of used motor oil could provide enough electricity to power 360,000 homes for one year, and

**WHEREAS**, over 200 million tires are thrown away each year. Thirty-five percent of all truck tires are recapped, but only 5% of passenger car tires are recapped. Used tires can be recycled to make airport runways, running tracks, highways and a variety of household products, and

**WHEREAS**, an average of 18% of the total landfill deposits in the United States are produced from tree trimmings, brush, leaves and grass clippings. Citizens can reduce this amount dramatically by simply instituting a home composting program. Compost ingredients decay in a few months and produce a mixture rich in nutrients that can be used to supplement soil and control weeds in gardens, lawns and flower beds, and

**WHEREAS**, recycling creates six (6) times as many jobs as landfills, and

**WHEREAS**, recycling is beneficial because it conserves valuable natural resources, reduces energy consumption in the manufacturing of goods, creates jobs, stimulates business development, extends the life of our landfills and reduces disposal costs.

**NOW THEREFORE, BE IT RESOLVED**, by the Anderson County Legislative Body meeting in regular session this 18<sup>th</sup> day of August 2008 that we:

**SECTION 1.**

Encourage our citizens, businesses and other governments to endorse a countywide recycling program with the goal of reducing landfill deposits 1% each year for the next twenty-five years.

**SECTION 2.**

Authorize the County Mayor and the Solid Waste Director to institute a comprehensive county government recycling program with the goal of increasing county government recycling 5% each year for the next three years and maintain or exceed that level for future years.

**SECTION 3.**

Authorize the County Mayor to immediately provide recycling receptacles in all county offices and buildings and form a joint committee with all elected officials and department heads to develop a recycling initiative.

**SECTION 4.**

Encourage the Anderson County School System to adopt a system-wide recycling program for students and staff.

**SECTION 5.**

This resolution shall take effect immediately the public welfare requiring it.

**RESOLUTION NO. 08-308**

**A RESOLUTION TO CLARIFY, DECLARE AND AFFIRM THE EMPLOYMENT STATUS OF ANDERSON COUNTY LIBRARY BOARD EMPLOYEES.**

**WHEREAS**, the Anderson County Board of Commissioners desires to clarify the employment status of Library Board employees by declaring that henceforth they shall be considered Anderson County Government employees, and

**WHEREAS**, all Library Board employees shall be offered the same employment benefits and privileges offered to other Anderson County employees of the same status, and

**WHEREAS**, pursuant to *Tennessee Code Annotated § 10-3-104*, "The board has the power to direct all the affairs of the library, including appointment of a librarian who shall direct the internal affairs of the library, and such assistants or employees as may be necessary." The various library employees will remain under the supervision and direction of the Library Board, and

**WHEREAS**, the Library Board and its employees shall follow all established Anderson County rules and regulations for budgeting, accounting, auditing, purchasing, employment procedures and the like, and shall adhere at all times to the Anderson County General Personnel Policy, and

**WHEREAS**, pursuant to *Tennessee Code Annotated § 10-3-103*, "Not more than one (1) official each of the county and of the city governing bodies shall serve on this board."

**NOW THEREFORE, BE IT RESOLVED**, by the Anderson County Board of Commissioners meeting in regular session in Clinton, Tennessee this the 18th day of August, 2008 that henceforth and pursuant to acceptance and formal adoption of this resolution by the Anderson County Library Board that:


**SECTION 1:** We hereby grant all rights, privileges and benefits associated with employment status with Anderson County Government to those respective employees of the Library Board.

**SECTION 2:** The Library Board and its employees shall be under a continuing obligation to comply with all established Anderson County Government rules, procedures, regulations and personnel policies.

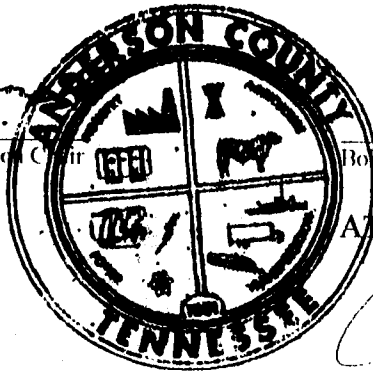
**SECTION 3:** The supervision and control of library employees shall remain with the Library Board and its appointed directors and supervisors.





**RESOLUTION NO. 08-307**

**A RESOLUTION TO APPOINT THE OFFICE OF THE ANDERSON COUNTY LAW DIRECTOR AS THE DELINQUENT BUSINESS TAX ATTORNEY FOR ALL BUSINESS TAXES ACCRUING IN ANDERSON COUNTY**

**WHEREAS**, pursuant to *Tennessee Code Annotated §§ 67-4-701* Anderson County has the lawful power and authority to impose and collect business taxes on businesses within the County in lieu of ad valorem taxes on inventory of merchandise held for sale or exchange, and

**WHEREAS**, Anderson County may levy a business tax under Tennessee state law for each business, business activity, vocation, or occupation not to exceed rates established by the Tennessee General Assembly, and

**WHEREAS**, all affected businesses within the County must register with the Anderson County Clerk, and

**WHEREAS**, the Anderson County Clerk is authorized to collect business taxes for the use and benefit of the County from these businesses, and

**WHEREAS**, under Tennessee state law, the Anderson County Clerk has the legal authority to retain an attorney for the purposes of collecting delinquent business taxes, interest and penalties for the County (*See, T.C.A. § 67-4-719*), and

**WHEREAS**, pursuant to that authority the Anderson County Clerk desires to retain the services of the County Law Director's Office for this purpose.

**NOW THEREFORE, BE IT RESOLVED** by the Anderson County Legislative Body meeting in regular session this 18<sup>th</sup> day August 2008 that:


**SECTION 1:** The Office of the Anderson County Law Director is hereby appointed to be the official collector of delinquent business tax in Anderson County.

**SECTION 2:** The County Law Director is authorized to collect delinquent business taxes, interest, penalties, court cost, service fees, and a fifteen percent (15%) collection charge from the delinquent taxpayer.


**SECTION 3:** All statutory fees, penalties and court costs allocated by general law to the County's Delinquent Business Tax Attorney shall be deposited in the general fund of Anderson County and shall not be retained by the County Law Director or staff.


**BE IT FURTHER RESOLVED,** this resolution shall not take effect unless approved by two-thirds (2/3) majority vote of the Anderson County Legislative Body.


