PROPOSED AMENDMENT TO THE ANDERSON COUNTY ZONING RESOLUTION

New Section: 075-070

Public Notice: Use on Review; Re-zoning; Variance and/or Special Exception Requests.

Notwithstanding any other provision of law or regulation to the contrary, including those embodied in this Resolution and specifically including Section 05-060 (Amendments to the Zoning Resolution), any request for rezoning, variance or special exception shall comply with the following public notice requirements in an effort to provide adequate notice to the general public and those property owners immediately adjacent to, and surrounding the subject property.

Prior to any official public meeting and/or public hearing where any re-zoning, variance or special exception will be considered for approval by the Board of Zoning Appeals, Planning Commission, or Board of County Commissioners, the following public notice requirements shall be completed:

- A) Newspaper of General Circulation in the County no less than fifteen (15) days prior to the meeting where the matter will be discussed and considered for approval the date, time, location of the meeting and proposed action to be taken or considered shall be published in at least two different newspapers regularly published and circulated in Anderson County. At least one of the newspapers shall be published in the county seat of Clinton, Tennessee and the other shall be regularly circulated in the locale nearest the property requesting the zoning change, variance or special exception. The published public notice shall also contain the applicant's name, address, map and parcel number for the subject property. Nothing contained in this resolution shall prevent the Planning and Community Development Department from charging the applicant/landowner reasonable fees for the mandatory notice publications listed in this section.
- B) Anderson County Television (ACTV) no less than fifteen (15) days prior to the meeting where the matter will be discussed and considered for approval the date, time, location of the meeting and proposed action to be taken shall be displayed on ACTV for no less than five (5) consecutive days prior to the meeting date. The displayed public notice shall also contain the applicant's name, address, map and parcel number for the subject property.
- C) Anderson County Website the meeting agenda for any meeting or public hearing of the Board of Zoning Appeals, Planning Commission and Board of County Commissioners where the proposed action will be discussed and considered for approval shall be displayed on the Anderson County Government website no later than the day after the agenda deadline and shall remain on the website until the day after the meeting date. The agenda shall specifically identify the proposed request or action to be taken, name of owner/applicant, physical address and the map and parcel number of the subject property,

including date, time and location of the meeting or public hearing where the matter will be discussed and/or considered for approval.

- D) Certified Mail Notification The owner/applicant of the subject property shall work with the Planning and Community Development Department to send all adjacent or contiguous property owners (including those property owners immediately across any public or private roadways) written notification of the meeting or public hearing date, time, location of the meeting and proposed action to be taken, no less than fifteen (15) days prior to the meeting where the matter will be discussed and considered for approval. The owner/applicant will at all times be responsible for the mailing and costs associated therewith for the certified mail notification(s). The Planning and Community Development Department will address and send all written notifications to the affected adjacent property owners and shall retain all return receipts demonstrating the adjacent property owners were notified of the proposed action and date, time and location of the meeting or public hearing. The Planning and Community Development Department may charge reasonable expenses to the applicant/land owner for the identification of the adjacent landowners, sending of the certified mail notices and retention of the receipt cards. The certified mail public notice shall also contain the applicant's name, address, and map and parcel number for the subject property.
- E) Property Posting and Signage Each property shall be continuously posted in a clear and conspicuous manner for a period of no less than fifteen (15) days prior to the meeting and/or public hearing where the matter will be discussed and considered for approval. Posting shall specifically state the date, time, location of the meeting and proposed action to be taken and shall also include the applicant's name, address and map and parcel number of the subject property. Signage shall be no less than two (2) feet by four (4) feet utilizing contrasting colors. The Building Commissioner shall have the authority to design and approve said signage and assign staff member(s) to post the subject property at the best desirable location on the subject property for accomplishing public notice. All required signage will be the responsibility of the Community Planning and Development Department.

INTERGOVERNMENTAL COOPERATION AGREEMENT

Blankenship Field Renovation Project

WHEREAS, Under Tenn. Code Ann. § 5-1-113 the county legislative body and the chief legislative body of any one (1) or more municipalities lying within the boundaries of the county are authorized and empowered to enter into any such agreements, compacts or contractual relations as may be desirable or necessary for the purpose of permitting the county and the municipality or municipalities to conduct, operate or maintain, either jointly or otherwise, desirable and necessary services or functions, under such terms as may be agreed upon by the county legislative body and the chief legislative body or the municipality or the chief legislative body of the municipalities; and

WHEREAS, the City of Oak Ridge is currently engaged in a reconstruction project to provide updates to the Blankenship Field Recreational Complex and is in need of construction equipment, trucks and personnel to finish said project; and

WHEREAS, the Anderson County Highway Department and its Superintendent have agreed to assist the City of Oak Ridge with such equipment and personnel needed for the purposes set forth in this agreement; and

WHEREAS, the City of Oak Ridge has agreed to compensate the Anderson County Highway Department for the use of said equipment and personnel, provided these expenses do not exceed \$5,000.00.

NOW THEREFORE, BE IT RESOLVED by the Anderson County Legislative Body and the City Council of Oak Ridge that we have agreed as follows:

- 1) The Anderson County Highway Department will assist in the reconstruction efforts of Blankenship Field by using equipment owned by the Department and associated personnel to operate this equipment and pursuant to the terms and conditions embodied within this agreement and directives and policies of the Anderson County Highway Superintendent.
- 2) The City of Oak Ridge will reimburse the Anderson County Highway Department for any expenses incurred in the usage of this equipment upon thirty (30) days of invoicing, provided these expenses do not exceed five thousand dollars (\$5,000.00).
- 3) The City of Oak Ridge assumes all liability related to the use of this equipment and releases and agrees to fully indemnify Anderson County and/or its Highway Department from any and all claims related to the equipment usage to the extent allowable by state law including the Governmental Tort Liability Act, except for incidents and/or accidents caused by the Highway Department and its personnel.
